An electronic version of the article on the disk or via email with the note "ASSOCIATION WITH THE EUROPEAN UNION" (the file named after the author in English and the attachment name must match the names of participant and an indication of material type conference Latin (eg: Vasylenko_Andrii_tezy, Vasylenko_Andrii_zaiavka).

Requirements for the papers

The structure of the article should contain the following elements:

- rationale and topicality of the problem;
- analysis of existing research in the field;
- singling out the aspects which have not been studied;
- goals and objectives of the article; justification of the results;
- conclusions, recommendations, prospects for further research;
- list of references;

- extended abstracts with key words in English - if these submitted in Ukrainian or Ukrainian - if these submitted in English. The volume of extended abstracts - 0,5-1 book page A-4. Abstract should have the following structure: name, surname of the author, title, text annotations, which provide detailed information on the content and results of research keywords.

Volume of publications - 3-5 pages (A4).

Technical parameters. Text is to be typed in Microsoft Office Word 2003 or later. *Font:* Times New Roman, size - 14 pt, spacing - 1.5 pt. *Margins:* left - 30 mm, right - 15 mm, top and bottom - 20 mm.

Placing. UDC is in the upper left corner. Full name, title, affiliation, academic degree of the author(s) should be indicated in the upper right corner.

Article title is to be typed in capital letters and centered. The summary (3-4 sentences) and key words in Ukrainian are 1 interval below the title. References in the text are to be given in brackets, where the first number is the number of sources in the reference list and the second is the page number. Reference number and page numbers are separated by commas, the numbers of sources by semicolons, e.g.: [1, 95-96] [see: 2; 5; 7].

The numbered list of REFERENCES is given in 1 interval below the text in alphabetical or sequential order. Publications editions printed in Cyrillic are given first. References are given according to the latest requirements of the Ukrainian State Standard. The summary (3-4 sentences) in English and Russian with keywords is given in 1 interval below the references.

ATTENTION! The Committee reserves the right to reject reports and articles that do not meet the above mentioned requirements, irrelevant to the conference topics and do not prove scientific novelty.
